**Information sought :**

The appellant file an RTI Application dated 21/07/2023 seeking Details regarding Expenditure and Implementation of fund under SADA/ADA/SIDF/RE/RIDF/BE under Kamle District.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 10/08/2023. No any hearing has conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Buli Bhai on **06.07.2023** filed an RTI application under Form-'A' before the PIO-cum-Dy. Director of School Education, Raga, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **10.08.2023**, Appellant, having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **19.09.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 924/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for twelve times i.e. on 18/12/2023, 19/01/2024, 01/04/2024, 10/06/2024, 29/07/2024, 02/09/2024, 07/10/2024, 02/12/2024, 13/01/2025, 24/02/2025, 26/03/2025 and 28/04/2025. In this hearing of the appeal on 28<sup>th</sup> day of April, 2025, both the parties, the PIO-cum-Executive Engineer (PWD), Raga Division and the appellant Shri Buli Bhai found absent. However, the appellant has sent a letter addressed to the Commission stating that all the information as sought by him has been furnished by the PIO and he is satisfied with the information provided and requesting to dispose off the Appeal Case No. APIC-924/2023.

The penalty amount of Rs. 25,000/- (Rupees twenty five thousand) only imposed against the PIO has been deposited through e-Challan. Copy of the same is submitted in the case record.

Therefore, the Appeal Case No. APIC-924/2023 is disposed off today on the request letter submitted by the appellant.
