JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri **Tania June C/o Post Office, Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by **PIO –cum- DFO Tawang, Tawang District, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 14.02.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

**“Regarding Expenditure and Implementation under Green India Mission (GIM) of entire Tawang District”.**

The above subject has been mentioned in detail under 'Form – A'.

The 1<sup>st</sup> hearing of this case was held on 22/11/2023. Both the Appellant and PIO was present. The PIO has furnished the information as sought by the appellant and handover the same to the appellant during the hearing of this case. After going through the same the appellant has expressed his satisfaction on receiving the sought information from the PIO and pleaded for disposal of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
