JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Tai David on 12/04/2024 filed an RTI application under Form-'A' before the PIO-Cum- Executive Engineer (PHE & WS) Division Tawang, District Tawang, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on 20/05/2024 the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 31/07/2024 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No. 227/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3 times i.e on 01/10/2024, 21/11/2024 & 2 30/01/2025. In this hearing of the appeal on 30^{th} day of January **2025**. Both the parties are present during the hearing.

However, the Appellant during the hearing has stated before the Commission that he has received all the information as sought in his Form 'A' application and has requested the Commission for disposal/closure of this appeal on ground of satisfactorily in receipt of all information sought from the PIO.
