JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Riya Taram, C/o Hotel River View, Barapani Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by the **PIO-cum-EE, PWD Tali Division, Camp Office Hapoli, Lower Subansiri District, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 17.12.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"To furnish all the relevant documents of Allocation of Fund Sanction under SIDF/ RE/Additional RE/BE /ADA/MLALAD/ MPLAD/ SPA/ SJETA/ CCI/ SADA/ CMCSR/ BADP which are implemented under PWD Tali Division for the year 2016 to 2023 (till date)."

The above subject has been mentioned in detail under 'Form - A'.

The 1st hearing for the case was held on the 28th day of June'2023. Both the parties were present. After hearing both the parties, the PIO informed the Court that he has not received the Form-A of the appellant. The Form-A was cross checked and it was found that the same had already been received by the PIO and accordingly, the PIO had been directed by the Court to provide the information sought by the appellant on or before the next date of hearing of this case on 26th day of July'2023.

The 2nd hearing of this case was held on the 26th day of July'2023. Both the parties were present. After hearing both the parties, the PIO has sought some more time due to his new joining as the PIO at the Tali Division. The next date of hearing of this case was fixed on the 13th day of Set'2023.

The 3rd hearing of this case was held on the 13th day of Sept'2023. Appellant was present and the representative of the PIO Shri Sorang Tagung, A.E Tali Sub-Division was also present. After hearing both the parties, the information sought by the Appellant was brought by the representative of the PIO and handed over to the Appellant during the hearing of this case. The appellant was directed to go through the same and inform his satisfaction/dissatisfaction on or before the next date of hearing of this case fixed on 04th day of Oct'2023.

On the 6th day of October'2023, the appellant sent an application (copy enclosed for ready references) stating that that he has received all the information as sought from the PIO-cum-EE, PWD Tali Division and is fully satisfied with the information provided by the PIO and pleaded before the Court for the disposal of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.

Above Cited Subject, I would Like to apprise your good Office for your kind consideration and necessary action please.


