**JUDGEMENT ORDER**

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Tania June, C/o Post Office, E-sector Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by **the PIO-cum-BDO, Huri-Damin CD Block, Kurung Kumey District, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 17.01.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

**“To furnish the details regarding Expenditure and Implementation of work under MGNREGA/ Supply Work/ Pending Work/ New Work from 2014 to till date. “**

The above subject has been mentioned in detail under 'Form – A'.

The 1<sup>st</sup> hearing for the case was held on the 22<sup>nd</sup> day of November'2023. The appellant was present. The representative of the PIO, Shri Yamra Tatup EO(RE) was also present. After hearing both the parties, the representative of the PIO informed the Court that they hadn't received the Form-A of the applicant till date. Later, the representative of the PIO had taken a photograph of Form-A during the Court proceedings itself. The Court directed the representative of the PIO to provide the information on or before the next date of hearing of this case. The next date of hearing of this case was fixed on the 20<sup>th</sup> day of Dec'2023.

The 2<sup>nd</sup> hearing of this case was held on the 20<sup>th</sup> day of December'2023. The representative of the PIO Shri Chakpu Bai (BFT CD Block Huri-Damin) was present. The appellant was also present. After hearing both the parties, the representative of the PIO had provided the information as sought by the appellant during the Court proceedings itself. The appellant received the same and after going through the same, the appellant stated that he is fully satisfied with the information provided by the PIO and further pleaded before the Court for the disposal of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
