**JUDGEMENT ORDER**

An appeal under section 19(3) of RTI Act, 2005 was received from Shri Likha Rajnik, Rayo Village, Nirjuli, ICR, Arunachal Pradesh, for non-furnishing of information, by The PIO-O/o The Chief Secretary, Civil Secretariat, Block No.2, fifth Floor, Itanagar, ICR, Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 18.01.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

***"Details of Govt. Officials land encroachers within capital complex Itanagar/Naharlagun/Nirjuli"***

**The above subject has been mentioned in detail under 'Form – A'.**

The 1<sup>st</sup> hearing was held on 09<sup>th</sup> day of August' 2023. Both the parties were present. The PIO informed the Court that the documents sought by the appellant is ambiguous and the most of the problems have already been taken up by the PIO-O/o the Chief Secretary. The appellant also agreed upon the same and expressed his satisfaction for the information received from the PIO. Hence the Court directed to dispose of the case and no such hearings for this case will be entertained further in the Commission's Court.

*Considering all the above aspects into account, I find this appeal fit to be disposed off as infructuous. And, accordingly, this appeal stands disposed off and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.*
