JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Riya Taram, Shri Lokam Tadam & Tap Sajan on **17/07/2023**, filed an RTI application under Form-'A' before the PIO-Cum- EE (WRD) Aalo Division District West Siang Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **21/08/2023**, the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **29/8/2023** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No.943/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for three times i.e on dated **12/11/2024, 16/01/2025 & 7/08/2025**, details of information(s) sought from the PIO.

Details of information sought by the Appellants.

- 1. To Furnish the Name of work/project/Scheme.**
- 2. Details of Project report (DPR) of every works.**
- 3. Give the Exact location of work site with GPS Co-ordinates photographs 3 in Coloring photo copy.**
- 4. Technical sanctioned (TS) of every works.**
- 5. Give the Measurement book (MB) Record with page numbers of every works/Activities.**
- 6. Provide the First and final Bill copy.**
- 7. Furnish the list of Name of contractors/Firms/power of Anthony/Enterprise/individuals with their Bank account Number/Cheque leaf/demand draft/Bankers Cheque/Cash Memo/Money receipt/billing challan/counterfoil/voucher who's the Bill has been passed/ Transferred through PFMS of every works.**
- 8. Give the Cash book with page number or Give Hand Receipt with payees Name**
- 9. Name of Works with GPS co-ordinates photographs/Geo-tag.**

10. Give the Work Order copy of every works.
11. Details of Social Audit copy.
12. Sanction order copy.
13. Give the Bank Account Statement of Department/Treasury before or after payment has made or Transaction to the contractor/Firm/individual/Enterprise /demand draft through PFMS.
14. Furnish the Filed Approved by District vigilance Officer cum - Deputy Commissioner West Siang District.
15. Provide details Expenditure or payment made.
16. Certified Copy of LOC/LOA copy receipt from finance department/ Chief Engineer office.
17. Copy of work completion Report/UC. 17
18. Furnish the details of third party Inspection Report.
19. Give the Coloring Photograph copy/Video recording of all the works site from first day of work initio to completed day of work with GPS Coordinates photographs/Geo-tag.
20. Copy of NIT copy whether it was published on local daily News paper or not if yes may furnish news paper cutting/Total number of tender participated.
21. Name of contractor/Firms/Enterprise along with Latest GST updates Number.
22. Details of Tender norms and guidelines/Tender Board committees who have been conducted the tender float process.
23. Give the Details of all the deduction of Money charges from Contractors as per govt. guidelines.
24. Furnish the Name of all Officers and officials those who have handled and in-Charge of mentioned Fund Utilization with their Designation and its signature.
25. Furnish the Cash book with page numbers or Give hand Receipt with payees Name/cash Memo/ Money Receipt of all the Supplies Items. If any Supply work.
26. Give the details of exactly Deduction charges of Money from Contractor/Firms/Enterprise
27. Estimate copy/Voucher/Cash Memo/Money Receipt of materials/items.
28. Furnish the staffs list like computer operator/peon, driver and casual labour with appointment order copy/ Education qualification of staffs.

In the final hearing on 7th day of August '2025, the Appellants and PIO both found absent during the hearing.

However, the Appellants Shri Shri Riya Taram, Shri Lokam Tadam & Tap Sajan, submitted a letter to the Commission on 14/02/2025 stating that they received all the information(s) as sought in their Form 'A' application and have requested the Commission for disposal/closure of their appeal on ground of satisfactorily in receipt of all information(s) sought from the PIO.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
