JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received **Shri Rai Lamrah, C/o Raja Biswas Cyber, Opp. Govt. Higher Sec. School, Model Vill. Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by the **PIO-cum-EE, Public Works Dept., CD-A Itanagar, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 22.12.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

1. C/o Drainage Slap at Niti Vihar near Maya Motors (project Cost – 50 lakhs)
2. C/o Boundary wall, main gate and paver block for internal road of Arunachal Bhawan & Circuit House Shillong (project cost 31.63 lakhs)
3. C/o Special Repair and maintenance of Arunachal Bhawan & Circuit House Shillong (project cost 43.77 lakhs) for the period 2020 to 2022.

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing of this case was held on the 28th day of June'2023. The appellant was present but the PIO was absent. During the hearing of this case, the Court/Commission directed the appellant to go to SE Capital Circle (PWD) for seeking the information sought as per his form-A. Hence, the case is disposed of with a liberty to file a fresh appeal to the FAA in PWD by the appellant.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
