JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri **G.F Rimo & Shri K Hissang, Papu-II, Near Aba Prayer Centre, Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by **PIO, O/o Director (Economics & Statistic) Gohpur, Itanagar, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 21.02.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"Total appointment list of FI, SI, LDC & UDC for the period from 2015 to 2022".

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing of this case was held on 22.11.2023. Appellant was present but the PIO was absent. The Commission seriously viewed the absence of the PIO and to Show Cause as to why he should not be imposed a reasonable penalty as provided in the Section 20(1) of the RTI Act, 2005 for violation of Sub Section (1) of the Section 7 of the RTI Act,2005 and failing which he shall be invoked with the Section 20(2) of the RTI Act,2005. Therefore, the PIO was once again directed to appear in person on the next date of hearing of this case fixed on 20.12.2023 along with all the replies to the information sought by the appellant and the reason of his absence on its previous hearing viz. on 22.11.2023.

The 2nd hearing of this case was held on 20.12.2023. The appellant was absent, but the PIO was present, and he has submitted the reply to the Show Cause issued against him and he has also furnished the information sought by the appellant the same was received by the appellant on 4th Jan,2024 (receipt of documents by the appellant is enclosed for ready references). The appellant was directed to go through the information received and has to intimate his satisfaction/dissatisfaction on or before the next date of hearing of this case fixed on 17.01.2024.

The 3rd hearing of this case was held on 17.01.2024. Both the parties were absent. The information sought by the appellant has already been provided and he was instructed to go through the same and should inform his satisfaction/dissatisfaction on or before today's hearing, but he was found absent, and he has not informed about the documents received which indicates that he is fully satisfied with the information received and does not want to pursue this case further. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
