- (i) Cash memo / vouchers copy of related expenditure, if any.
- (j) Cheque receipt copies of contractor and firms.
- (k) Details names list of contractor and firms to whom the amount payment, date of payment and cheque numbers.
- (l) LOC demanded and released copies and DPR copies.
- (m) Furnish Trading License and proprietor Name List copies.
- (n) Furnish works order copies CAMPA and all the schemes.
- (o) Furnish, if any MLA notes sheet copies all the schemes.
