**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Minli Ete for non-furnishing of 6(six) point information regarding c/o Nehru Road to Darka Road PMGSY by the PIO, o/o the E.E (RWD), Aalo, West Siang District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 19.03.2025.

The appeal has been listed for hearing on 26.11.2025 and 28.01.2026.

On 26.11.2025 the PIO was absent without any intimation but the appellant, Shri Minli Ete was present in person who, reiterating his demand for the requested information had pleaded for an appropriate direction to the PIO to furnish the information/documents and also for penal action against him for violating the provisions of RTI Act and not complying the order of this Commission.

This Commission, taking serious note of the PIO's non-appearance without intimation had cautioned him that if he fails to appear in the next date on 28<sup>th</sup> January, 2026, this Commission shall be constrained to invoke the penal action under the relevant provisions of the RTI Act, 2005. He was also directed to furnish the requested documents to the appellant and report compliance thereof on 28.01.2026.

Today on 28.01.2026, the appellant is present in person but the PIO is absent. The PIO, the EE (RWD), Aalo Division, however, forwarded his letter dt. 27.01.2026 to the appellant by which he has furnished the requested information/documents. The copy of the said letter which this Commission has received in Whatsapp, shows that the requested information as per the RTI queries of the appellant have been furnished to the appellant except the reply to Sl. No.4 (handing and taking over of the road from the PWD) which is remarked as "NA".

This Commission holds that the reply to the RTI query has to be specific and not vague as "NA" and as such the PIO is directed to furnish specific reply to the said query. The appellant is also directed to go through the documents despatched by the PIO through speed post and intimate to this Commission within 1(one) week from today and not later than 6<sup>th</sup> February for further consideration of the appeal by this Commission.
