JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Riya Taram on 15/5/2023 filed an RTI application under Form-'A' before the PIO-Cum- EE RWD, Tawang Division, District Tawang, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on 30/6/2023 the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 3/7/2023 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No. 709/2023 and processed the same for its hearing and disposal.

Heard both the parties.

Accordingly, matter came up for hearing before the Commission for three times i.e on 7/11/2024 & 19/12/2024 & 6/3/2025. In this hearing of the appeal on 6th day of March'2025 .The PIO present during the hearing through online mode and the Appellant Shri Riya Taram present during the hearing in person.

The Appellant stated before the Commission that the PIO has provided all the information as sought in his Form 'A' application and has requested the Commission to dispose his appeal on ground of satisfactorily in receipt of all information sought from the PIO.

The Commission observes;

The Appellant request to dispose the instant appeal leaves no further need to carry on the hearing, so this appeal be disposed.

Pursuant upon the procedural laws and provision of RTI Act 2005 and considering the request of the Appellant to dispose this appeal and as above the Commission hereby orders;

In view of the above facts and circumstance the Commission find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed.
