JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Ebo Mili on 09.12.2022 filed an RTI application under Form-'A' before the PIO-Cum- PCCF (WL & BD), Itanagar, P/Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 14.01.2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 15.05.2023 and the Registry of the Commission (APIC), having receipt of the Complaint, registered it as **APIC No. 448/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the **Commission for 4 (four) times i.e on 26.06.2023, 07.08.2023, 20.11.2023 & 20.12.2023. In this hearing of the appeal on 12th day of December, 2023. Both the parties present during the hearing.**

However, the appellant intimated to the Commission that as per the direction of the Commission in the last hearing dated on 20/11/2023, the PIO has furnished the information in affidavit by rectifying the errors. So, he is fully satisfied and requested for disposal/closer of their appeal on the ground of satisfactorily receipt of all the information sought from the PIO.

In view of the above facts and circumstances, I find this appeal fit to be disposed of and closed. And, accordingly, this appeal stands disposed of and closed for once for all.
