ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Ijip Taso, for non-furnishing of below mentioned information by the PIO, o/o the DFO Likabali, Lower Siang District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 22.07.2024.

This appeal was heard on 16th May, 2025 wherein both the PIO and the appellant were represented by their respective Counsels namely, Advocate, Shri Lizar Bui and Advocate, Shri Dope Ori respectively.

This Commission, upon hearing the Ld. Counsels and on perusal of the documents/information requested by the appellant in his application dt.22.07.2024, noticed that the documents / information requested by the appellant for 4(four) schemes and for 6(six) financial years (2019 to 2024) was, indeed, indiscriminate and disproportionate, as contended by the Ld. Counsel for the PIO, which is against the principle of law settled by the the Hon'ble Supreme Court of India in its judgment & order dt.09.08.2011 passed in Civil appeal No. 6454 of 2011 {arising out of SLP (C) No. 7526 - 2009) in the matter of CBSE & Anr. Vs. Aditya Bandopadhyay & Ors..

However, in order that the intent and the objective of the RTI Act is achieved, this Commission felt it just and appropriate to direct the PIO to furnish the documents / information requested by the appellant against four schemes (at Sl.No.1,2,3 and 4 of his RTI application) not at one go but in a span of 4(four) months starting from the month of May, 2025. The PIO was, accordingly, directed that he shall, at first instance, provide the documents/information against any one scheme out of the four within one month from today. Thereafter, the document/information against remaining three schemes shall be provided in a span of three months.

The appellant, Shri Ijip Tasso, however, informed vide his application dt.20.06.2025 that the PIO did not furnish the documents as directed and hence, pleaded for hearing the appeal again.

The appeal, thus, listed again for hearing today on 25.07.2025. However, the appellant, vide his letter dt.25.07.2025 sent through WhatsApp at 12.00 noon, intimated that the PIO has furnished the requested information to him vide letter dt.24.07.2025, a copy whereof has also been enclosed in his letter.

In the premises above, this appeal does not require any further adjudication and resultantly it stands disposed of and closed and the hearing fixed today is hereby cancelled.
