ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tania June, c/o of Post Office Naharlagun Arunachal Pradesh for non-furnishing of information by the SPIO-cum-DLRSO, Govt. of A.P. O/o Department of Land Settlement Officer, Likhabali, Lower Siang District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 10/02/2023 regarding Expenditure and implementation of under Trans Arunachal Highway (TAH) Land Compensation payment of entire Lower Siang District.

The 4th hearing is held today on 26th March, 2024 as scheduled. Shri Chogge Nyodu, the SPIO-cum-DLRSO, Govt. of A.P. O/o Department of Land Settlement Officer, Likhabali, Lower Siang District, Arunachal Pradesh alone is present. The Appellant shri Tania June is absent. The PIO has submitted that subject matter of the information is related to project of 2014 onwards. During that time all the functions were covered by Aalo, West Siang District. The present Lower Siang District was not created that time. As such information sought for are not available with the PIO Likhabali. Hence, he has made several correspondences with the concern PIO of Aalo for transferring the information so that same can be furnished to the Appellant but there is no response from his counterpart. Considering the circumstances and records available the commission decides to dispose of the case with liberty of the Appellant to apply fresh application to the PIO-cum-DLRSO, Aalo West Siang District.

During the last hearing it was clearly directed to the appellant to appear before the commission, failing which the case will be disposed of without any further notice. Since, the appellant is absent the commission decides to dispose of the case.

Therefore, the case is hereby disposed of.
