ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, Shri Bengia Tahar & Shri Lokam Namdu. for non-furnishing of below mentioned information by the PIO, o/o Executive Engineer (HPD), Hawai Division, Govt. of Arunachal Pradesh, as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 29.08.2024.

a) Particulars of information: To furnish all the Relevant Information as per your furnished name of work list copy which enclosed here with against the (SIDF)/SADA/BE/RE/Scheme from 2018 to 2023.

b) Details of information Required:

- 1. Furnish the List of Scheme.
- 2. Give the Name of Work List with Geo-tag Report/ Sanction Order/Technical Sanction (TS)copy.
- 3. Give the(DPR)/Estimate copy.
- 4. Furnish the List of Work Order & Name of works list with Cheque book counterfoil/cheque leaf /demand draft/Banker cheque/Challan and PFMS Transaction details of bill payment as according to the amount which Mentioned in Work Order/Sanction Order/name of work list.
- 5. Furnish name of contractors/Firm/Enterprise with their bank account number.
- 6. Give the deposited Slip/Voucher/Challan of GST Amount/Money which deposited to . Govt. Account from Firm/Enterprise account with GST updates.
- 7. Give the Xerox copy of all the Trading License/Firm/Enterprise.
- 8. Furnish the deposited treasury Challan of GST Money deposited to the Government Account by Executive Engineer, Hydro Power Hawai Division.
- 9. Details of payment with Money Receipt of Contractors/Firm/Enterprise.
- 10. Give Bank Account Statement of EE Hydro Power Hawai Division with their account number.
- 11. Give the letter of LOC/LOA which wrote to the Branch Manager of State Bank of India to release of fund to Executive Engineer account by Chief Engineer PWD
- 12. Give (MB) with page number/hand receipt and payees name.

13. Give first and final bill copy / give the name of various deduction as percent from contractor payment.

14. Give the photocopy of work site before starting of work / completion of work

site with exact location.

15. Give certified photocopy of all work site by concern officer.

- 16. Give the name of officers and officials who handled /executed the works.
- 17. Furnish the description of work site location before start of work.
- 18. Furnish the billing details sheet copy of work/scheme details sheet copy of
- 19. Furnish NIT copy /date of NIT tender float/total number of bidder/total apply of Firms /name of selected firm/enterprise and contractors /press letter paper cutting /awarded firm details/cheque book counterfoil/leaf with account number of firm contractor to whom the payment has been made /UC.

Brief facts emerging from the appeal:

Records in the appeal disclose that the Appellants, Shri Riya Taram, Shri Bengia Tahar & Shri Lokam Namdu had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted them to appeal before the Chief Engineer (E/Z) Govt. of A.P Hydro Power Department Itanagar, the First Appellate Authority under Section 19 (1) of RTI Act, 2005 vide his Memo of Appeal dated 30.09.2024. However, the appellants failed yet again to obtain the information and therefore, they preferred 2nd appeal before this Commission under Section 19 (3) of the RTI Act. 2005 vide his Memo of Appeal dated 17.02.2025...

This appeal is accordingly, listed and heard today on 28.05.2025 wherein the PIO, Er. Shri Dharmen Gogoi, EE appeared through VC but the appellants are represented by Shri C.L. Mannao.

Heard the PIO who submitted that in response to the RTI application of the appellants, his office had requested the appellants to seek information against specific schemes as the period of information sought pertains to last 5 (five) years. In this regard the PIO has produced the copy of his letter dt. 03.10.2024 to the appellants which the PIO claimed never responded to by the appellants. The PIO, on query, however, submitted the appellants could be provided with the information/documents for the 2(two) financial years (2019-2020 and 2020-21) against the funding head SADA saying that no schemes under the SIDF were implemented during the FY-2018-19.

This Commission, as assured to by the PIO, directs him to provide the information / documents to the appellants within 1(one) month from the date of receipt of this order and the appellants shall, within 1(one) week thereafter, intimate this Commission of the receipt of the same failing which this appeal shall stand closed without further notice.
