**Information sought :**

The appellant file a RTI Application dated 07/08/2023 seeking Details regarding Services status of Shri Ide Rime and Shri Anando Biswas, Drivers, Dte. of Health Services.

As per the case record, PIO has never conducted the hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 19/09/2023. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tok Changsing on **07.08.2023** filed an RTI application under Form-'A' before the PIO-cum-Director of Health Services, Directorate of Health Services, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **19.08.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **29.08.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 229/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 10/03/2025. In this hearing of the appeal on 10<sup>th</sup> day of March, 2025, the PIO-cum-Dy. Director, Health Services and the appellant Shri Tok Changsing present in person before the Commission.

Heard from both the parties and gone through the case record. It is seen that information as sought by the appellant in Form 'A' application has been provided. The appellant has stated that the information sought at Sl. 2 has been provided but not been certified by the PIO. PIO is ready to certify the copy already provided to the appellant on being produce before him.

Therefore,, the appeal case No. APIC-229/2024 is disposed off in presence of both the parties.
