JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Tania June, C/o Post Office Naharlagun, E-Sector, Arunachal Pradesh**, for non-furnishing of information, by the **PIO-cum-EE, RWD Sagalee Division, Papumpare District, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 19.12.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"To furnish the details of Expenditure and implementation under SADA/ADA/PMGSY/SIDF/RIDF/CSS of entire 15-Sagalee Assembly Constituency for the period from 2010 to till Date."

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on the 03rd of May'2023. The PIO was absent but the appellant was present. The case was heard ex-parte. Since, the PIO was absent, the matter couldn't be discussed further. As such, the court has fixed the next date of hearing of this case on 31st day of May'2023.

The 2nd hearing for the case was held on the 31st day of May'2023. The PIO was present and the representative of the appellant Shri Nikam Dabu was also present. Heard both the parties. The Court directed the PIO to furnish the Sanction Order Copies only of the period as mentioned in the Form-A of the appellant on or before the next date of hearing of this case fixed on the 21st day of June'2023.

The 3rd hearing of the case was held on the 21st day of June'2023. Appellant was present but the PIO was absent. The case was heard ex-parte. The next date of hearing of this case was fixed on the 5th day of July'2023.

The 4th hearing of this case was held on the 5th day of July'2023. Appellant was present but the PIO was absent. The Commission/Court seriously viewed the two consecutive absence of the PIO and therefore, a Show Cause Notice was issued against the PIO as to why a reasonable penalty shouldn't be imposed against you as per the RTI Act,2005. The next date of the hearing of this case was fixed on the 2nd day of August'2023.

The 5th hearing of this case was held on the 2nd day of August'2023. Appellant was present and the representative of the PIO, Shri B. Tayem A.E RWD Sagalee was also present. Heard both the parties. Information sought by the appellant was provided by the representative of the PIO during the Court proceedings itself and handed over to the appellant. The appellant should go through the same and should inform his satisfaction/dissatisfaction on or before the next date of hearing of this case fixed on the 17th day of August'2023.

The 6th hearing of this case was held on the 17th day of August'2023. Appellant was absent but representative of the PIO, Shri B. Tayem A.E RWD Sagalee was present. Information sought by the appellant had been provided by the representative of PIO during the court proceedings itself and handed over to the Court. The Commissioner's office would contact the appellant to collect the same. The appellant should go through the same and should inform his satisfaction/dissatisfaction on or before the next date of hearing of this case fixed on the 13th day of September'2023.

The 7th hearing of this case was held on the 13th day of September'2023. The appellant was present but the PIO was absent. The appellant informed the court that he is fully satisfied with the information provided by the PIO and pleaded for the disposal of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
