JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Tania June on **07.10.2023** filed an RTI application under Form-A before the PIO-cum-District Medical Officer, Department of Health Aalo, West Siang District, Govt. of Arunachal Pradesh, whereby, seeking various information, as quoted in Form-A application. Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **05.12.2023**. Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **31.01.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC-No.92/2024** and processed the same for its hearing and disposal.

Accordingly, this matter came up for hearing before the Commission for once i.e. on **02.04.2024**. In this final hearing of the appeal on **02.04.2024** the PIO-cum-DMO Seppa, East Kameng found present during the hearing, but the appellant found absent during the hearing. However, the appellant submitted a letter to the Commission through whatsapp that he has received all the information as sought in his Form 'A' application and has requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information sought from the PIO.

In view of the above facts and circumstances I find this appeal fit to be disposed off and closed. And, accordingly, this appeal stands disposed off and closed once for all.
