**Information sought :**

The appellant file a RTI Application dated 20/11/2024 seeking Details regarding C/o Construction of Circuit House at Balemu, West Kameng District.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 20/12/2024. First Appellate Authority has been conducted hearing in his jurisdiction on 06/02/2025. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**The following were present.**

Appellant : Shri Mamu Sono absent.

Respondent : PIO-cum-EE(PWD), Kalaktang Division attended the hearing through VC.

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mamu Sono on **20/11/2024** filed an RTI application under Form-'A' before the PIO-cum-EE(PWD), Kalaktang Division, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **26/12/2024**, Appellant, again having not received the

required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 27/02/2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 225/A/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) time i.e on 19/11/2025 and 28/01/2026. In this hearing of the appeal on 28<sup>th</sup> day of January, 2026, PIO-cum-EE(PWD), Kalaktang Division, West Kameng District attended the hearing through VC but the appellant Shri Mamu Sono found absent without any intimation to the Commission.

On the last hearing dated 19/11/2025, the PIO had stated that the document sought by the appellant was ready to be furnished but the appellant never came to collect the information. The appellant was directed to collect the information from the office of the PIO and intimate to the Commission. The Commission had cautioned the appellant that if he is found absent in the next hearing, the case will be decided in his absence. Today the appellant is found absent without any intimation to the Commission. Therefore, the Commission deems that the appellant is no more interested to pursue this appeal case.

Therefore, this Appeal No. APIC- 225/A/2025 is disposed of and closed in his absence.
