JUDGEMENT

(ii) **The Appellant is given liberty to file a fresh application in the same case, if the PIO does not comply the order of this Commission within one week from today.**

In view of the above, facts and circumstances this Commission find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed.
