Information sought :

The appellant file a RTI Application dated 29/04/2024 seeking Details regarding all official correspondence relating to action taken related to DPC.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 08/09/2024. No any hearing has conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Tagam Mibang absent.
Respondent : PIO-cum-Under Secretary (Personnel) present.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tagam Mibang **29.04.2024** filed an RTI application under Form-'A' before the PIO-cum-Under Secretary (Personnel), Civil Secretariat, Itanagar, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **08.09.2024**. Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **13.12.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 402/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 29/01/2025 and 17/03/2025. In this hearing of the appeal on 17th day of March, 2025, the PIO-cum-Under Secretary (Personnel) present in person but the appellant Shri Tagam Mibang found absent without any intimation to the Commission.

During the hearing the PIO has stated before the Commission that all the information sought by the appellant has been provided to the appellant. The queries No. 1 & 3 are related to third party information so we cannot provide the information.

On the last hearing dated 29/01/2025 the appellant has stated before the Commission that he has received the information but not complete. The Commission directed the appellant to submit in written to the PIO within 7 (seven) days for seeking rest of the information. He did not oppose the PIO's regarding the third party information.

Therefore, the Commission deems fit to dispose off the case on the basis of statement made today by the PIO and failing of the appellant to convince the court that third party information is of larger public interest.

Accordingly, the appeal case No. APIC-402/2023 is disposed off and closed once for all.
