JUDGEMENT ORDER

An appeal under section 19(3) of RTI Act, 2005 was received from **Shri Riya Taram & Shri Takam Sakap, C/o Hotel Riverview Barapani, Naharlagun, Itanagar Capital Region, Arunachal Pradesh**, for non-furnishing of information, by **The PIO-cum-Executive Engineer, Rural Works Department, Laying Yangte Division, Kurung Kumey District, PIN-791118, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 03.03.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding :

"To furnish all the relevant documents regarding allocation of fund sanctioned under SIDF/RE/Additional RE/BE/ADA/MLALAD/MPLAD/SPA/SJETA/CCI/SADA/CMCSR/SIDF & Additional/BADP, which implemented under all the CD Blocks of 21st Koloriang Assembly Constituency."

The above subject has been mentioned in detail under 'Form - A'.

The 1st hearing for the case was held on 22nd day of November' 2023. The appellant was absent but the PIO was present. Mr. Tania June represented the case on-behalf of the appellant. Heard both the parties. The representative of the appellant informed the Court that PIO haven't yet furnished any documents. The Court directed the PIO to furnish the documents sought by the appellant on or before the next date of hearing fixed on 20th December' 2023.

The 2nd hearing was held on 20th day of December' 2023. Both the parties were present. Heard both the parties. After hearing both the parties the Court directed the PIO to furnish all the relevant documents pertaining with SIDF 2019-20 and BE 2022-23 on or before next date of hearing fixed on 17th January' 2024.

The 3rd hearing was held on 17th day of January' 2024. Both the parties were absent. Since, both the parties were absent the matter couldn't be discussed further. As such the Court fixed another date of hearing for the case on 31st January' 2024.

The 4th hearing was held on 31st day of January' 2024. The appellant was absent but the APIO was present. The APIO furnished the remaining documents before the Court itself(enclosed). Since the appellant was absent for 02(two) consecutive hearings without any intimation to the Court. The Court seriously viewed the absence and presumed that the appellant is satisfied with all the documents provided by the PIO and doesn't want to pursue the case further. Hence, the Court directed to dispose of the case and no such hearings for this case will be entertained further in the Commissions' Court. The remaining documents furnished by the PIO in the Court is enclosed with the appellant's Order copy.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
