**Information sought :**

The appellant file an RTI Application dated 27/02/2023 seeking Details regarding Implementation of MGNREGA Scheme.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 29/05/2023. No any hearing was conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Techi Gambo Tara **27.02.2023** filed an RTI application under Form-'A' before the PIO-cum-Block Development Officer, Balijan, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **29.05.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **31.08.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 857/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3(three) times i.e on 29/01/2025, 17/03/2025 and 21/04/2025. In this hearing of the appeal on **21<sup>st</sup> day of April, 2025**, the PIO-cum- BDO, Balijan, Papum Pare District present in person but the appellant Shri Techi Gambo Tara, found absent without any intimation to the Commission. During the hearing the PIO has stated that all the information as sought by the appellant has already been furnished to the appellant and submitted a receipt same before the Commission today.

As per the case record, the appellant was absent on the last hearing dated 17/03/2025 and today also appellant is found absent.

The Commission deems that the appellant has received the information and he is satisfied by the information provided to him.

Therefore, the Commission deems fit to dispose off the appeal case No.APIC-857/2023. Accordingly, the appeal case is disposed off and closed.
