**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Miss Bengia Mama on **14/10/2024** filed an RTI application in Form- 'A' before the PIO-cum-Assistant Director, Textile and Handicraft, Yupia Papumpare District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application; The Appellant not being provided with the information by the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **22/11/2024**. Appellant again having not received the required information from the FAA, filed the second Appeal before the Arunachal Pradesh Information Commission on **06/02/2025** and the Registry of the Commission (APIC) having receipt of the complaint registered it as **APIC- 121/2025 (Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **22.04.2025 & 10.07.2025**. Details of information(s) sought from the PIO;

1. Furnish latest photos (Photograph) of the project in coloring photos.
2. Furnish material procurement of challan.
3. Furnish latest physical progress report of the project in coloring photos.
4. Furnish photography of project before during and after the completion of the project in coloring photo.
5. Furnish list of selected beneficiaries and its details & exact project location.
6. Furnish asset creation register.
7. Furnish beneficiaries signed registers.
8. Furnish photographic evidence and receipt of the assets in kind mode, distributed to the beneficiaries to be collected and submitted at the time of execution of the scheme as per the guidelines of the scheme.
9. Furnish monthly report of the district officers along with the attached site photographs in color submitted to director of textile handloom and handicraft.
10. Furnish detailed report with photo of 3rd party monitoring conducted by Central Silk Board (CSB), Ministry of Textile Government of India.
11. Furnish all the sanction orders/copy.
12. Furnish name of the CBOs, SHGs and Mahila Resham Karmis's who are supported for the implementation of the said project.
13. Furnish the detailed documents including coloring photos of the training for women Sericulturists/Spinners/Weavers being organized by the State Dept. in association with Regional Silk Technology Research Station (RSTRS), CSB, Guwahati.
14. Furnish the name of the beneficiaries who took assistance towards fencing of ERI Plantation, Kessaru Sappling, and Rearing Tray, coloring photo copy of fencing (barbed wire), Kessaru Sappling, and Rearing Tray and detailed procurement of challan/bills.



15. Furnish name & total number of Rearing House and colouring photos of the Rearing House must be constructed as per DPR comprising of Bricks, Mortar & GI Sheet with Pucca Floor.
16. Furnish detailed of the Common Facility Centre for On-Farm activities for labour reduction and higher output. Also, furnish detailed documents like procurement of challan for equipments/machineries.
17. Furnish the details of Common Facility Centre for Spining with Ambar Charkha unit. Also Furnish material procurement of challan on Ambar Charaka Set, Spinning Wheels, cost of accessories and miscellaneous (erecting, commission and maintenance cost).
18. Furnish the name and detailed qualification of Facilitators.
19. Furnish the details of Equipment for Community Facility Centre for CFC.
20. Furnish the detailed Documents, (including material procurement of challan/bills & coloring Photos of the material etc.) of the support for establishment of Centre of Excellence Equipments. Like Training Equipment, Equipment of Incubation, Silkworm Rearing, Mounting and Harvesting, Equipments for Testing of Quantitative and Qualitative Characters of Cocoon, Dormitory Equipment, Equipments for Display Room and Laboratory and Generator.
21. Reply all the above mentioned Documents in point wise as well as in proper paging with CTC in each page.

In the final hearing both the parties are absent, whereas the Appellant submitted a prayer latter for withdrawal of this instant appeal on stating that she has received all the information(s) from the PIO.

**Order;**

In view of the above facts and circumstance the Commission, finds this appeal fit to be disposed and closed. And, accordingly, this Appeal stands disposed and closed once for all.
