**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tania June, c/o of Post Office Naharlagun Arunachal Pradesh for non-furnishing of information by the SPIO-cum-EE(UD & Housing), Govt. of A.P. O/o UD & Housing, Palin KraDaadi District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 11/01/2023 regarding expenditure & implementation under SADA/ADA/SIDF/RIDF/RE/CSS/ of entire KraDaadi District.

**The 2<sup>nd</sup> hearing is held today on 17<sup>th</sup> October, 2023 as scheduled.** Er. Nich Jacob, SPIO-Cum-EE (UD & Housing), Govt. of A.P. O/o UD & Housing, Palin Kra Daadi District, Arunachal Pradesh is present and the Appellant Shri Tania June is found absent. During the hearing SPIO is present with the remaining information sought for but in absence of the Appellant information could not hand over the same. The SPIO has submitted that as per the directions of the Commission the Appellant was to visit the office of the SPIO for collection of the information but has not collected so the SPIO could not furnish the information to the Appellant. The Appellant is absent so the SPIO is directed to hand over the information brought by him to the Appellant personally. During the last hearing it was clearly directed to the Appellant to attend the next hearing, failing to which the Commission will disposed of the case without further notice presuming that the Appellant is satisfied with the information so furnished. The absence of the Appellant during the hearing and failure to collect the information from the SPIO's office shows that the Appellant is not interested in access to the information.

Considering the fact that the SPIO has complied with the directions of the Commission and the Appellant has failed to do so. The Commission came to its conclusion to disposed the case.

Hence, the case is disposed of and closed.
