Information sought :

The appellant file an RTI Application dated 14/08/2023 seeking Details regarding Relief Fund for damage like Cardamom, banana, bamboo etc. in Kamle District of Arunachal Pradesh.

As per the case record, PIO did not furnish the sought information

Being dissatisfied, the appellant filed First Appeal dated 14/09/2023. The FAA has been conducted the hearing on 08/04/2025. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Palen Laa present in person.

Respondent : PIO-cum-DDMO, Raga attended hearing through VC.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Palen Laa & Smti Yukar Yaga on **14.08.2023** filed an RTI application under Form-'A' before the PIO-cum-District Disaster Management Officer, Raga, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **14.09.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **08.04.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 1011/2023 (R)/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 14/07/2025 & 08/10/2025. In this hearing of the appeal on 8th day of October, 2025, the appellant present in person and the PIO-cum-District Disaster Management Officer, Raga, Kamle District attended the hearing through VC.

The PIO stated that the sought information has been furnished as per Form 'A' application sought by the appellant. The appellant has also stated that he has received the information as per the Form 'A' but PIO has furnished information other than the Form 'A' application as well.

The information sought has been furnished to the appellant as per Form 'A' application. If any other information required apart from the Form 'A' application, he may file fresh application for seeking the information before the concerned department. The appeal case is therefore, disposed of and closed.

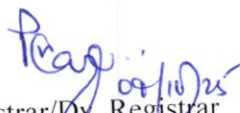
