**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri G.F. Rimo, Papu-II, Near Govt. Pry School, Papu village, Naharlagun, PO/PS Naharlagun, District Papum Pare, Arunachal Pradesh for non-furnishing of information by the State Public Information Officer (SPIO), Govt. of A.P. o/o Bomdila Forest Division, West Kameng District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 09/05/2023 regarding CAMPA FUND, 2022 to 2023.

**The 3<sup>rd</sup> hearing is held today on 26<sup>th</sup> March, 2024 as scheduled.** Shri Chuku Loma, the PIO-cum-DFO, Govt. of A.P. o/o Bomdila Forest Division, West Kameng District, Arunachal Pradesh is represented by Shri Gollo Nera, LDC. the Appellant Shri G.F. Rimo are absent. The representative of the PIO informed that on the 2<sup>nd</sup> hearing the main cause of absence of the PIO was due to his ill health. The PIO has been to hospital and was advised by the Doctor to take bed rest. In support of his submission the PIO has submitted the documents issued by the doctors. The PIO also vide Memo No. BD/11/RTI/2018/244-47 Dated the 8<sup>th</sup> March, 2024 informed that the appellant has been provided with the information through Registered post vide Article no. RE4062090051N, Trans ID No. SL0264130021705388618 on dated 16/01/2024. The representative of the PIO further informed that the appellant has not furnished any list till date.

The Commission observed that the appellant has been furnished with the information by the PIO. The appellant has not intimated either to the Commission of his satisfaction or dissatisfaction of the information furnished by the PIO, nor has submitted any list of information to be furnished by the PIO. The Commission in view of the cautioned to the appellant in the 2<sup>nd</sup> hearing held on 16<sup>th</sup> January, 2024 decides to dispose of the case presuming that the appellant has received the information and is satisfied with the same.

**Therefore, the case is disposed of.**
