Information sought :

The appellant file an RTI Application dated 20/06/2023 seeking Details regarding Appointment order of UDC/LDC/PEON/Driver/WCT/WCR/Chowkider/All MTS posts under the establishment.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 19/08/2023. No any hearing has been conducted by the First Appellate Authority. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Palen Laa & Smti Yukar Yaga absent.
Respondent : PIO-cum-DFO, Daporijo Forest Division absent.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Palen Laa & Smti Yukar Yaga **20.06.2023** filed an RTI application under Form-'A' before the PIO-cum-DFO, Daporijo Forest Division, Upper Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **31.08.2023**. Appellant, again having not received the required information from the FAA.

filed the Second Appeal before the Arunachal Pradesh Information Commission on **22.09.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 927/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for thirteen times i.e on 18/12/2023, 19/01/2024, 27/03/2024, 03/06/2024, 03/07/2024, 18/09/2024, 30/10/2024, 20/11/2024, 18/12/2024, 05/02/2025, 19/03/2025, 23/04/2025 and 11/06/2025. In this hearing of the appeal on 11th day of June, 2025, both the parties, the PIO-cum-DFO Daporijo Forest Division and the appellant Shri Palen Laa & Smti Yukar Yaga found absent.

On the 11th hearing dated 19/03/2025 the PIO has stated that information as sought by the appellant was ready to be provided to the appellant. The appellant was directed to collect the information from the office of the PIO-cum-DFO, Daporijo Forest Division and intimate to the Commission on or before next date of hearing.

On the 12th hearing date 23/04/2025 the PIO stated that all the information as sought by the appellant has been provided and he has contacted with the appellant. The appellant requested the PIO to send the information through postal address and accordingly, the PIO sent the information to the appellant through postal service. Copy of the information provided has been received by the Commission.

Last chance was given to the appellant to intimate regarding receipt of the information from the PIO to the Commission.

Today on 13th hearing the appellant is again found absent. Sufficient chance has been given to the appellant. The Commission presumed that the appellant has received all the information as sought from the PIO and he is satisfied with the information. The commission deems fit to dispose of this appeal case in absence of both the parties. The appeal case is disposed of and closed.


