**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Ashok Sangbia on **04/06/2025** filed an RTI application under Form-'A' before the PIO-Cum- EE, PWD Bameng Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **07/07/2025**, the Appellants again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **12/08/2025** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No-656/2025(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1<sup>st</sup> hearing on **20<sup>th</sup> Jan'2026**.

**Details of information sought by the Appellants:**

- a) Category of work charged (W/C) serving under your division and sub-division.
- b) Appointment letter of all the W/C staff serving under your division and sub-division.
- c) Place of posting of all the W/C staff serving under your division and sub-division.
- d) Approval from competent Authority CE or SE, advertised details, Interview or viva voice detail, videography during written exam conducted, along with board formed then details of all the W/C staff recruited under your division and sub-division.
- e) Present strength of W/C staff under your division and sub-division.
- f) New strength of or against retirement or vacate of W/C staff under your division and sub-division.
- g) Total sanction strength of W/C staff under your division and sub-division.
- h) Recruitments rule (RR) of W/C staff serving under your division and sub-division.

Period for which information asked for:-2018 to till date

The first hearing held on 20.01.2026 related to APIC-No. 656/A/2025 the Appellant present during the hearing before the Commission.

The PIO-cum-EE, RWD, Bameng Division, East Kameng District, Seppa, Govt. of Arunachal Pradesh is represented by the APIO-cum-Assistant Engineer, RWD, Bameng Division, Shri Logo Rang (Assistant Engineer).

Heard the Appellant;

The Appellant stated that he has sent the Form-A to the PIO through Registered Post from Seppa Post Office on 04.06.2025 and as per the record it was delivered to the PIO, and it was received on the same date as their office is just nearby the Post Office, Seppa.

Heard the APIO;

The APIO stated that they have not received the Form-A of the Appellant till today. And therefore, they could not take any action on the application of the Appellant.

The APIO again stated that he has photocopied the Form-A of the Appellant from the office of the Arunachal Pradesh State Information Commission (APIC) only and after that all the information(s) available with the PIO have been provided to the Appellant in the court of the Commission.

**After hearing both the parties the Commission hereby decides;**

1. The APIO has provided all the information(s) that the Appellant has sought and the Appellant received the copies of the information(s) from the APIO inside the office in the court of the Commission, today.
2. Pursuant upon the complete information(s) provided by the PIO to the Appellant the Commission hereby decide this instant appeal to be disposed of and closed.

**Order:**

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed of and closed. And accordingly this appeal stands disposed and closed once for all.
