JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Mamu Sono on 17/06/2024 filed an RTI application under Form-'A' before the PIO- Director Land Management (DLM), Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **26/07/2024** the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **5/11/2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 406/2024(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission i.e on 13/03/2025. In this hearing of the appeal on 13th day of March 2025. The Appellant Shri Mamu Sono and the PIO present during the hearing.
