

JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri **Samchan Changmi, Miao, PO/PS-Miao, Changlang District, Arunachal Pradesh**, for non-furnishing of information, by **PIO –cum- EE,RWD Miao, O/o SE RWD Miao Circle, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 21/03/2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

“Certified copies of NIT,Tender Board/Committee proceedings,DPR,UC under the maintenance of PMGSY Road of Changlang District, Roads & Bridges of Changlang Division,Soil and Water Conservation of Changlang Division,SIDF 2021-2022 under Changlang Division,”.

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing of this case was held on 22/11/2023. The representative of the PIO Er Hage Dogung,AE(P&D) RWC Miao represented on behalf of the PIO. But the Appellant was absent. The Case was heard ex-parte. The information sought by the appellant is found to be vague after going through his Form A owing to which the Court has decided to dispose of the case with a liberty given to the appellant to file a fresh of the case seeking specific information from the concerned authority which has been communicated verbally to the appellant also who had reached the court lately after hearing of this case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
