Information sought :

The appellant file a RTI Application dated 19/07/2024 seeking Details regarding 18th Review Meeting details on 29th & 30 Nov, 2023 and its implementation of RPWDS Act, 2016 etc.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 07/11/2024. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Soma Yangfo present in person.
Respondent : PIO-cum-Director, SJETA attended the hearing through VC.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Soma Yangfo on 19.07.2024 filed an RTI application under Form-'A' before the PIO-cum-Director, SJETA, Itanagar, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 07.11.2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 17.12.2024 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 22/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) time i.e on 28/05/2025 & 11/08/2025. In this hearing of the appeal on 11th day of August, 2025, the PIO-cum-Director, SJETA, Govt. of Arunachal Pradesh, Itanagar attended the hearing through VC and the appellant Shri Soma Yangfo present in person.

The PIO has stated that all the information sought by the appellant has already been provided and the PIO also showed receipt copy of the information provided to the appellant.

The appellant also later accepted that he was provided the information sought. The appeal case is therefore, disposed of and closed.

Judgment/Order pronounced in the open Court of this Commission today on this 11th day of August, 2025. Each copy of Judgment/Order be furnished to the parties.


