Information sought :

The appellant file an RTI Application dated 28/10/2024 seeking Details regarding C/o Road on Periphery of Shergaon township 5 KM (SG:FC, Culvert, Kacha drain & on layer of CSBC wherever necessary).

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 29/11/2024. No any hearing has been conducted by the First Appellate Authority. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Mamu Sono absent.

Respondent : PIO-cum- EE(PWD), Kalaktang Division present in person.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mamu Sono on **25.10.2024** filed an RTI application under Form-'A' before the PIO-cum-EE (PWD), Kalaktang Division, West Kameng District,

Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **29.11.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **24.02.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 210/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 17/11/2025 and 21/01/2026. In this hearing of the appeal on 21st day of January, 2026, PIO-cum-EE(PWD), Kalaktang Division present in person but the appellant Shri Mamu Sono found absent without any intimation to the Commission.

As per the order dated 17/11/2025, the PIO has stated that the information sought by the appellant has already been furnished through postal service (Tracking ID of the documents is enclosed). The appellant was cautioned on the last hearing that if he is found absent in the next hearing, the appeal case will be heard in his absence. Today the appellant is found absent without any intimation in spite of giving summon notice through postal service and through his personal whatsapp.

The Commission presumes that the appellant has received all the information and the appellant is satisfied by the information provided.

Therefore, the appeal case No. 210/A/2025 is disposed of and closed.
