ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Taguk Dada, Polo Colony, Naharlagun, Po/Ps, Naharlagun, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-DFO, Govt. of A.P., Likabali Division, Lower Siang District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 08/05/2023 regarding **State CAMPA Scheme 2020-21 & 2021-22 (CA Component-Volume-I)**.

The 2nd hearing is held today on 19th March, 2024 as scheduled. The SPIO-cum-DFO, Govt. of A.P., Likabali Division, Lower Siang District, Arunachal Pradesh is represented by Adv. Lizar Bui. The Appellant Shri Taguk Dada is absent. The representative of the PIO submitted that one case cannot be heard parallel in two courts. Further, has submitted that the First Appellant Authority (FAA) has issued summon notice for the 5th time, the last summon notice on 12th March, 2024 but the appellant remained absent before the FAA court. During the 1st hearing held on 5th December, 2023 the counsel of the PIO was present but without any authorization so he was not allowed to appear on behalf of PIO. This time in the 2nd hearing the counsel is present with authorization.

Considering the facts and circumstances as above and the caution given on 1st hearing held on 5th December, 2023 the commission decides to dispose of the case.

Therefore, the case is hereby disposed of.
