JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte on 30.03.2023 filed an RTI application under Form-'A' before the PIO-Cum- EE, WRD Division, Raga, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 04.05.2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 19.06.2023 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 573/2023 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 4 (four) times i.e on 14.09.2023, 30.11.2023, 11.12.2023 & 29.01.2024 In this hearing of the appeal on 29th day of January,2024. Both the parties found absent during the hearing.

However, the appellant submitted a letter dated on 24/11/2024 to the Commission that the PIO has furnished all the information as sought by him in his form 'A' application and requested for disposal/closer of his appeal on the ground of satisfactorily receipt of all the information as sought from the PIO.

In view of the above facts and circumstances, I find this appeal fit to be disposed of and closed. And, accordingly, this appeal stands disposed of and closed once for all.
