Brief fact of the case is that the appellants Shri Tamchi Gungte 29/10/2024 filed an RTI application under Form-'A' before the PIO-Cum- Executive Engineer(WRD), Bomdila Division, West Kameng, District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 27.11.2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 17/01/2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 87/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) times i.e on 14/07/2025 and 08/10/2025.
