JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri **Tania June C/o Post Office, Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by **PIO –cum- EE RWD Likabali Division, Lower Siang District, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 24.01.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"Regarding Expenditure & Implementation under SADA/ ADA/ SIDF/ PMGSY/ RIDF/RE /MLALAD Fund of entire Lower Siang District".

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing of this case was held on 17.08.2023. Both the parties were absent. Hence, the case couldn't be heard. The next date of hearing of this case is fixed on 13.09.2023.

The 2nd hearing of this case was held on 13.09.2023. Both the parties were present. After hearing both the parties the Court/Commission directed the PIO to furnish the Sanction Order Copy to the appellant as per his Form A on or before the next date of hearing of this case fixed on 04.10.2023.

The 3rd hearing of this case was re-scheduled on 19.10.2023. The appellant was represented by Shri Nikam Dabu and the PIO was represented by Shri J. Doye, JE RWD. As instructed to the PIO in its pervious hearing the representative of the PIO has handed over the only left out information viz. sanction order copies to Shri Nikam Dabu during the hearing of this case and hence the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
