FACTS OF THE CASE:

The appellant filed an RTI application dated 20.03.2023 seeking information on various works and SADA, ADA and SIDF/RIDF executed by the EE, RWD, SINGCHUNG Division. The PIO did not reply to the RTI application. The appellant then filed a First Appeal dated 21.04.2023 before the SE-cum-FAA, RWD, RUPA Circle, West Kameng. First Appellate Authority's (FAA) order, if any, is not available on record. Feeling aggrieved, the appellant approached this commission through this instant Second Appeal.

FACTS EMERGING DURING THE HEARING:

After receipt of the second appeal notices was issued to the parties to appear on 17.11.2023. The PIO appeared along with the requisite information and sought for permission to hand over the same to the appellant which was allowed. Accordingly, the appellant received the information from the PIO and requested for reasonable time for verification of the information. The commission allowed him the same. Commission adjourned the case to 25.01.2024.

Both the parties are present during the hearing. The PIO has informed that he has come with the remaining information and requested for permission of the commission to hand over the same to the appellant. The appellant has received the

information before the commission and stated that information has been furnished to his satisfaction.

DECISION:

Keeping in view facts of the case and submissions made by the parties, the commission is of the opinion that complete information has been provided by the PIO. The appellant has also showed satisfaction with the information provided. No further action lies. The instant appeal **stands disposed** of accordingly.


