**JUDGEMENT ORDER**

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri Tadar Chania & Shri Giogi Talam, Polo Colony Naharlagun, Arunachal Pradesh, for non-furnishing of information, by PIO-cum-EE, UD & Housing, Capital Division, Itanagar, Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 08.07.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

***"Regarding C/o Road with CC Pavement and drainage at Lor Putung near Zoo Road Itanagar "***

The above subject has been mentioned in detail under 'Form - A'.

The 1<sup>st</sup> hearing of this case was held on 15.02.2023. Both the parties were present. Heard both the parties. During the hearing of the case the PIO has explained on all the sought information by the appellant and the appellant was convinced by the explanation of the PIO and most of the information has already been provided by the PIO to the appellant. So, after detailed discussion the case was disposed of as the appellant has expressed his satisfaction. Hence, the case is disposed of.

On 22<sup>nd</sup> Feb,2023 the PIO has sent, an intimation letter addressed to the appellant with a copy to the Information Commission relating to payment made through Demand Draft its actual amount and other details (copy enclosed for ready references).

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
