Information sought :

The appellant file a RTI Application dated 09/10/2024 seeking Details regarding C/o Construction of Road from Hija-II to IPU, Ziro.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 19/11/2024. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Tamchi Gungte absent.
Respondent : PIO-cum-EE(PWD), Ziro Division present in person.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte on **09/10/2024** filed an RTI application under Form-'A' before the PIO-cum-EE(PWD), Ziro Division, Lower Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **19/11/2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **17/03/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 250/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3 (three) time i.e on 10/09/2025. In this hearing of the appeal on 10th day of September, 2025, the PIO-cum-EE(PWD), Ziro Division, Lower Subansiri District present in person but the appellant Shri Tamchi Gungte found absent however, he sent a letter addressed to the Commission requested to dispose of the appeal case No, APIC-250/2025.

Request accepted and this appeal case is disposed of and closed.

Judgment/Order pronounced in the open Court of this Commission today on this **10th day of September, 2025**. Each copy of Judgment/Order be furnished to the parties.

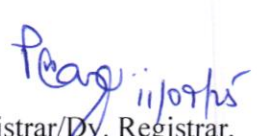
