JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant, Shri Tamchi Gungte, on **25/04/2023** filed an RTI application in form 'A' before the PIO-cum-EE, PWD, Yazali Division, Lower Subansiri District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not satisfied with the information received from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **13/06/2023**. Appellant again having not received the required information from the FAA, filed the Appeal before the Arunachal Pradesh Information Commission on **25/07/2023** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as **APIC- No. 673/2023 (Appeal)** and processed the same for its hearing and disposal.

Heard the Appellant;

Accordingly, matter came up for hearing before the Commission on 05.11.2024, 17.12.2024 & 04.03.2025. In the final hearing of the Appeal on 04.03.2025, the Appellant present and the PIO found absent.

However, the Appellant stated before the Commission that all the information(s) sought by him have been furnished to him by the office of the PIO and the Appellant requested the Commission for disposal of this instant appeal.
