## ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Nabam Pekhi, Village Taib, Po/Ps- Yazali, Lower Subansiri District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE( UD & Housing) Govt. of A.P. Department of UD & Housing Division, Ziro, Lower Subansiri District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 18/09/2023 regarding C/O Taib village Primary School Teacher Quarter Building infrastructure development of GPS Taib under Mission Shiksha Schemes.

The 1<sup>st</sup>hearing is held today on 30<sup>th</sup> May, 2024as scheduled. Shri Nich Jacob, the PIO-cum-EE( UD & Housing) Govt. of A.P. Department of UD & Housing Division, Ziro, Lower Subansiri District, Arunachal Pradesh, and the Appellant Shri NabamPekhi are present. The PIO has submitted that he has furnished replies and all the information as sought for by the Appellant. On the other hand the Appellant has submitted that he is not satisfied with the information furnished by the PIO. But did not specify the reasons for his dissatisfaction.

The Commission after going through the records available and submission made by the PIO, it is found that the information sought are vague, and voluminous. In observance of the clause (b) of subsection(1) of section 6 and subsection (9) of Section (7) of the RTI Act, 2005 the Commission has decided that information seekers should seek information for one financial year, of one specific work in one application so that the PIO can furnish information within prescribed period without disproportionally diverting the public resources.

The Commission also observes that the matter has not been heard by First Appellate Authority (FAA) which is mandatory under the RTI Act, 2005.

Therefore, the appeal case is remanded to the FAA with the direction to summon both the parties within 30(thirty) days from the issue of this order. Give equal and fair opportunities of being heard in the interest of the natural justice and pass speaking orders on merit. The Appellant is at his liberty to file fresh appeal to the Commission if he is aggrieved or not satisfied with the decision of the FAA.

Therefore, the case is hereby closed and disposed of.
