**Information sought :**

The appellant file a RTI Application dated 25/03/2025 seeking Details regarding construction of Fish Hatchery at Hollongi in Papum Pare District.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 06/05/2025. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Miss Bengia Mama on 25/03/2025 filed an RTI application under Form-'A' before the PIO-cum-EE (UD & Housing), Itanagar, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 06/05/2025, Appellant, again having not

received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **18/06/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC-503/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1(one) time i.e on 11/02/2026. In this hearing of the appeal on 11<sup>th</sup> day of February, 2026, the appellant Miss Bengia Mama present in person but the PIO-cum-EE (UD & Housing) found absent without any intimation to the Commission.

Appellant has submitted a letter addressed to the State Information Commission requesting to dispose of the appeal case No, APIC-503/A/2025. As per the prayer made by the appellant the appeal case is disposed of and closed.
