JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Dongru Tania, Near Takar Complex, PO/PS-Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by **the PIO-cum-BDO, Sagalee, Papumpare District, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 09.03.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"To furnish the details regarding Expenditure and Implementation of work under MGNREGA/ Supply Work/ Pending Work/ New Work/ Sanction Order/ Complete Work from 2010 to till date. "

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on the 22nd day of November'2023. Both the parties were present. The PIO has requested the Court to ask all the appellants relating to such case to come up to his office on 29.11.23, they would sit together and avail a training program on procedure to obtain the information from the website and inform the outcome of the same on or before the next date of hearing of this case. The next date of hearing of this case was fixed on the 20th day of Dec'2023.

Later, on the 20th December'2023 before the 2nd hearing of this case the appellant submitted an application (copy enclosed for ready references) intimating to dispose of the case as he is fully satisfied with the information provided by the PIO. Hence the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.



Therefore, I highly request you to kindly disposed off/close the above mentioned APIC No.499/2023 at early possible.



Brief fact of the case being that the appellant on 30.01.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

“To furnish the details regarding Expenditure and Implementation of work under MGNREGA/ Supply Work/ Pending Work/ New Work/ Sanction Order/ Complete Work from 2014 to till date. “

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on the 22nd day of November'2023. The appellant was present but the PIO was absent. A 2nd Summon Notice was issued to the PIO for his personal appearance on the next date of hearing of this case. The next date of hearing of this case is fixed on the 20th day of Dec'2023.

The 2nd hearing of this case was held on the 20th day of December'2023. The appellant was present. The PIO was also present. After hearing both the parties, the PIO had provided the information as sought by the appellant during the Court proceedings itself. The appellant received the same and after going through the same, he stated that he is fully satisfied with the information provided by the PIO and further pleaded before the Court for disposal of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
