JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri Toko Nikam, O/o the Aam Aadmi Party, Opp. Forest Nursing, 3rd Floor Nikia Building, Papunallah, Arunachal Pradesh, for non-furnishing of information, by the PIO-cum-Dy.SPD Samagra Shiksha/ISSE Itanagar, Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 07.07.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"Early Childhood Care and Education Centre for the period from 2019 to till date".

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing of this case was held on 21.12.2023. The appellant was present, and the APIO Shri Nabam Shelly was also present. After hearing both the parties the Court directed the APIO to furnish the left-out information to the appellant on or before the next date of hearing of this case fixed on 31.01.2024.

The 2nd hearing of this case was held on 31.01.2024. The appellant was absent, but the APIO Shri Nabam Shelly was present and informed the Court that he has already furnished the left-out information to the appellant on 04.01.2023.and the receipt copy of the same is provided to Court/Commission for reference. Since, all the sought information has already been provided by the PIO/APIO and the appellant was found absent on today's hearing. The Court presumes that the appellant is fully satisfied with the information provided to him and he does not want to pursue this case further. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
