**JUDGMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Tania June on 21/12/2022 filed an RTI application under Form-'A' before the PIO-Cum- Director, Department of Sports, Itanagar, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 15/02/2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 28/03/2023 and the Registry of the Commission (APIC), having receipt of the Complaint, registered it as APIC No. 256/2023 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 6 (six) times i.e on 15.05.2023, 12.06.2023, 24.07.2023, 04.09.2023, 16.10.2023 & 04.12.2023. In this hearing of the appeal on 4<sup>th</sup> day of December, 2023. Both the parties found absent during the hearing.

However, the appellant has submitted a letter to the Commission through whatsapp during the hearing that he has received all the information as sought in the Form-' A' application and requested for disposal/closer of his appeal on the ground of satisfactorily receipt of all the information sought from the PIO.

In view of the above facts and circumstances, I find this appeal fit to be disposed of and closed. And, accordingly, this appeal stands disposed of and closed for once for all.
