**JUDGEMENT ORDER**

An appeal under section 19(3) of RTI Act, 2005 was received from **Shri Rai Lamrah, C/o Raja Biswas Cyber, Opposite Govt. Hr. Sec. School, Model Village, Naharlagun, ICR, Arunachal Pradesh,** for non-furnishing of information, by **The PIO-cum-Executive Engineer, Rural Works Department, Itanagar Division, ICR, Arunachal Pradesh,** as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 09.12.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

**"Untied Fund(2021-2022)".**

**The above subject has been mentioned in detail under 'Form - A'.**

The 1<sup>st</sup> hearing was held on 28<sup>th</sup> day of June' 2023. Both the parties were present. Heard both the parties. The APIO represented the case on-behalf of the PIO. The APIO informed the Court that the documents sought by the appellant had been already furnished to him. The appellant had received the same. The appellant informed the Court that the documents furnished by the APIO weren't done with proper CTC. The Court directed the APIO to re-furnish the documents to the appellant with proper CTC tomorrow and the case was disposed of in the Court itself since all the documents sought by the appellant have been furnished by the PIO. Both the parties agreed the Court's final verdict. Hence, the case is disposed of and no such hearings for this case will be entertained further in the Commission's Court.

***Considering all the above aspects into account, I find this appeal fit to be disposed off as infructuous. And, accordingly, this appeal stands disposed off and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.***
