**Information sought :**

The appellant file an RTI Application dated 31/08/2023 seeking Details regarding Covid-19 Pandemic of Itanagar Capital Complex.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 05/10/2023. No any hearing has been conducted by the First Appellate Authority. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Dongru Tania **31.08.2023** filed an RTI application under Form-'A' before the PIO-cum-DFO, DDMO, Itanagar Capital Complex, Papum Parei District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed

the First Appeal before the First Appellate Authority on **05.10.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **09.11.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 1036/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for thirteen times i.e on 27/01/2025, 24/02/2025, 26/-03/2025, 28/04/2025 and 11/06/2025. In this hearing of the appeal on 11<sup>th</sup> day of June, 2025, the Appellant Shri Dongru Tania present in person but the DDMO, Itanagar Capital Complex, found absent without any intimation to the Commission.

Summon letter issued to the PIO is returned unserved for twice. On the last 2 occasion the appellant was directed to give the correct address of the PIO. The last 2 times so that summon could be issued to the PIO but the appellant could not give complete/new address where the summon copy could be sent.

Sufficient chance has been given to the appellant. The appellant is present and with his consent the appeal case is disposed of and closed today.


