**ORDER**

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV 2 School, Chimpu, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(PWD), Dept. of PWD, Naharlagun Division, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 14/08/2024 regarding **Construction of High Court Building at Naharlagun, Arunachal Pradesh.**

2). The 1<sup>st</sup> hearing was held on 21<sup>st</sup> January, 2025 (Tuesday) at 1100 hrs. The Appellant Shri Tamchi Gungte, was found absent during the Court hearing. Shri Pema Dorjee Khochi, AE, Naharlagun Sub- Division No. IV, PWD AP, Naharlagun represented the PIO-Cum- Executive Engineer, PWD, A.P., Naharlagun. He informed the Commission that all the information as sought by the Appellant was furnished in the form of Soft & Hard copy. The Appellant Shri Tamchi Gungte has received the documents and signed in the office copy on 21/11/2024 Vide Office Memo No. ND/RTI-351/TG/2024-25 Dated 14/11/2024.

3). The Commission observed that after receipt of the document and on completion of 2 months period no written correspondence has been made by the Appellant about his satisfaction and dis-satisfaction on the matter. So, it is presumed that the Appellant is satisfied with the information so furnished by the Appellant.

4). Based on the input provided by the PIO-Cum- EE (PWD), A.P. Naharlagun, the Commission assumed it fit to dispose of the case.

Therefore, the case is hereby disposed.
